MEETING

Organization Outline Overview

- Discussion of list of "purposes" with group and asked for any changes to outlines be brought to attention, nothing in particular proposed. The organizational outline will be brought to the Membership Meeting on August 9th for discussion.
- Non-Profit LLC Formation discussion with no objection

Membership

- Discussion of membership structure/youth inclusion/dues
 - Discussion was made to combine Pilot and Student Pilot Membership
 - Student pilot certificate holders would be considered same as any pilot member, full dues and voting rights
 - Youth, or those individuals who are interested in aviation but not currently a student pilot certificate holder, would be welcomed. Must be sponsored by a paid member and will not have dues or voting rights.
- 5 member groups discussed; ultimately came to a conclusion of 3 member groups (Pilot Members, Associate Members and Youth Members)
- Payed Members have vote; Pilot Members and Associate Members pay dues
- Pilot Members include Pilot or Student Pilot certificate holders
- Associate Members are non-pilots who have an interest in aviation, this would include spouses
- Board will set actual rates at first Directors meeting; There was discussion that the board should set a lower dues cost for student pilots.

Association Name

- Discussion was made about Association name, should it be Central Kentucky or Kentucky Pilots Association.
- The room was scanned and the consensus was Kentucky Pilots Association name chosen and to be presented to Members at August 9th meeting.
- Some discussion of a logo and styles were presented.

Association Structure

- Meetings every second Thursday
- 30% for quorum, majority votes of present members

Directors/Officers

- Officers discussed, currently do not have a Membership Chairperson or Secretary. Of those present who were approached for Director/Officer/Committee position, they have agreed to those positions.
- Nominations for those positions will be made at the next member meeting, Aug. 9

Membership Meetings

- Room discussed ATC issues at KSDF Approach as an example of member struggles that could be addressed at a Membership meeting. Possibly have a "fly a controller" day and/or a meeting where an ATC representative comes to discuss ATC/Pilot communication techniques and etiquette
- Have proficiency lectures at monthly meetings.

AvGas Motor Fuel Tax
